On 13 September, members from the AV team, children's ministry, ushers and staff in the main hall and children's room will commence a trial set-up at the new venue.

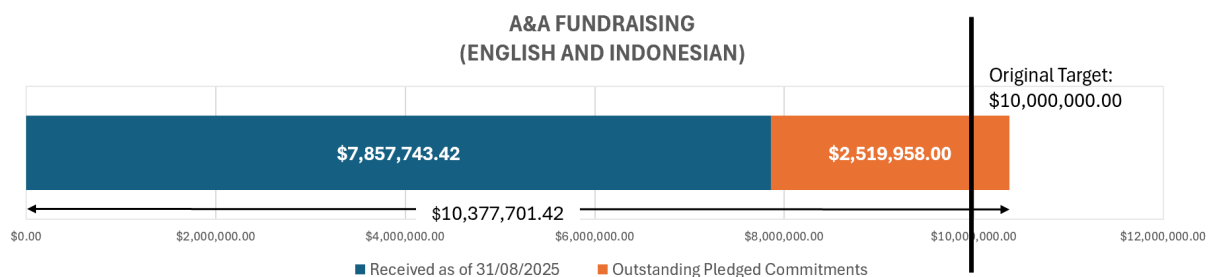

3. Technical Updates

We have been granted the provisional permission from URA for works to be conducted on the Dunman Building. There shall be no commencement of works for the proposal for the main church building until approval for commencement of works is granted by URA.


4. Fundraising Updates - We have surpassed our \$10 mil target!

We thank God for providing us the funds, hitting our \$10 million target through actual and pledged donations. With the total building cost of \$23 million, raising more than \$10 million will help us to offset potential unexpected expenses and reduce the draw-down effect on our reserves.

RESENTMENT & RESTORATION

Find hope for mending broken relationships and forgiveness through the lens of God's grace

28 SEPTEMBER 2025

A broken relationship is one of the most painful experiences in life. Since the fall of Adam and Eve, God's people have had to deal with the challenge of forgiving others when they hurt us, with little or no success. What hope do we have for mending broken relationships?

In this SoCM Sunday Class, we will examine the subject of forgiveness in terms of the Bible's teaching and what this may look like in everyday relationships. Secondly, our discussion will focus on the power of the Gospel to help us forgive others. Lastly, we will consider a biblical example of reconciliation in Paul's letter to Philemon.

NOMINATION & ELECTION OF ELDERS AND DEACONS

Session is calling for an Extraordinary Congregational Meeting (ECM) for the election of Elders and Deacons to be held on **Sunday, 16 Nov 2025**. Those elected will serve a three-year term from 1 January 2026.

ORPC members are encouraged to nominate ORPC ministry/DG members who have been serving faithfully in ORPC and demonstrated leadership qualities, for election as Elders or Deacons.

The closing date for nominations is **Sunday, 5 October 2025**.

Session will interview all candidates with their spouses (if any). Those who qualify and are deemed to be suitable nominees will be recommended and announced to the congregation on three Sundays (26 Oct, 2 & 9 Nov 2025) prior to the election date.

To be duly elected, candidates must receive at least (a) two-thirds of the votes cast for Elders and (b) half of the votes cast for Deacons.

WHAT DO ELDERS AND DEACONS DO?

Elders and Deacons are voluntary office bearers in the Congregation. They join the pastoral staff in pastoral leadership and oversight, oversee the management of ORPC, assist in the administration of ORPC and in all matters concerning the building-up and growth of ORPC.

Elders serve primarily in Session and may also be appointed to the Board of Management (BoM). Session is the final decision-making body in ORPC and has particular responsibility for the spiritual mission and growth of ORPC.

Deacons serve in the BoM and have particular responsibility for the pastoral care of God's people and for managing the material resources of ORPC to serve its spiritual mission.

WHO CAN BE NOMINATED AND ELECTED?

- Elders and Deacons must meet the biblical qualifications according to 1 Timothy 3:1-13 and Titus 1:6-9.
- Nominees must be communicant members of ORPC for more than three years.
- All nominees are expected to have served in at least one area of ministry in ORPC for a minimum period of one year prior to being nominated.
- Elders must have served for at least one term of three years as a Deacon.
- Spouses of Elders and Deacons must also be communicant members of ORPC. Divorcees and those with previously-divorced spouses do not qualify for nomination.

- Elders and Deacons must assent to the basic creeds and confessions of the Presbyterian Church, the Apostles' Creed, the Westminster Confession of Faith, the Constitution of the Synod of the Presbyterian Church in Singapore and the Constitution of ORPC.
- Elders and Deacons must assent to and carry out the vision and mission of ORPC to do Disciple-Making Church.
- Elders and Deacons are expected to be regular in attendance at worship, leadership and congregational meetings e.g. Session/Board of Management meetings, life-stage / ministry / committee meetings as assigned, Leaders Onboarding, Leaders' Equipping & Training, Leaders Retreat, Annual / Extraordinary congregational meetings. They will also undertake other duties relevant to their office and other assigned responsibilities as decided from time to time.
- Nominees must not be or have been disqualified to be a member of the Board of Management or Session by virtue of the Charities Act, chapter 37 of Singapore, or any other statute, law or regulation.

HOW TO NOMINATE?

Elders and Deacons must be proposed and seconded by other communicant members of ORPC.

A member who wants to nominate another member should first check the eligibility of that other member (please see above) before making any nomination.

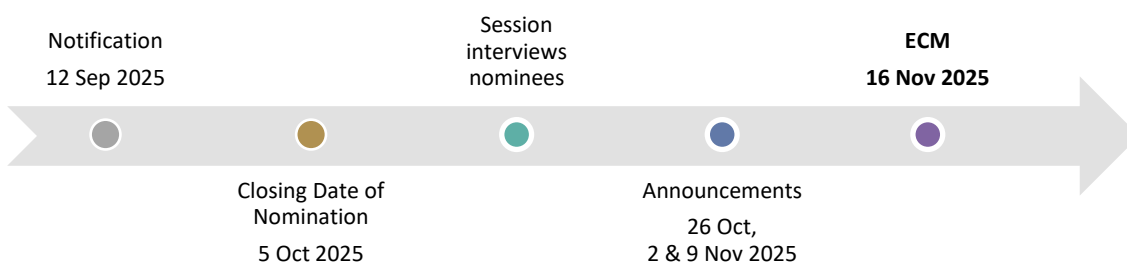
The proposer needs a seconder for the nomination. After both the proposer and the seconder have signed the nomination form, the nominee must sign the form to confirm his/her consent to the nomination.

Nomination forms are available on our website or the Church Office. All completed nomination forms must be submitted, for the attention of the Session Clerk, to the English Congregation Executive (yongpingping@orpc.org.sg) by **Sunday, 5 October 2025**.

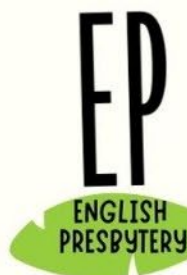
