3. Appointment of Main Contractor and Commencement of Work

We thank God for bringing forth 6 pre-qualified building contractors who submitted bids for the A&A work. Thank God for the clear and decisive evaluation process which led to the selection and approval by Session of Lum Chang Interiors Pte Ltd as the main contractor for our A&A project. We also thank God for the completion of a comprehensive conservation survey work on the main Sanctuary building. Please pray for God's guidance and wisdom as we work with the Multi-Disciplinary Team led by Formwerkz Architects and the URA Conservation Division on the full scope

of works that need to be carried out on the Sanctuary building. A subsequent tender process will be called for the Conservation/Refurbishment work which will be included in the main contract as "Nominated Subcontractor".

We are pleased to report that the project is currently both on schedule as well as within our planned budget.



4. Fund Raising Matters

We are continuing to work on raising funds despite having reached the targeted \$10 million in funds pledged and received. This will help us cover any unforeseen contingencies and help to reduce the drawdown on our church's financial reserves which is a significant contributor to our operating income through the investment returns of these funds.
