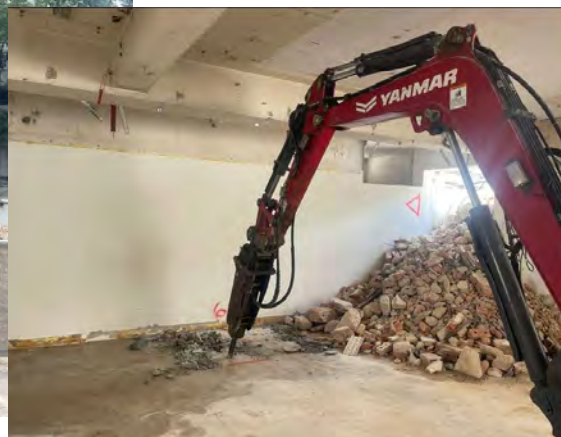

2. Sanctuary Restoration Nominated Sub-contractor

We have nominated Lum Chang Interiors Pte Ltd as the sub-contractor for the Sanctuary restoration works in end-April 2026. Lum Chang Interiors has already been engaged as our main contractor.

Three contractors were pre-qualified, with two submissions. There were two rounds of tender interviews and adjustments.
